A new statutory University, namely, Sikkim Manipal University of Health, Medical and Technological Sciences, Gangtok, Sikkim has been established by an Act of Sikkim Legislative Assembly (Act-9 of 1995) and notified in the Sikkim Government Gazette vide No. 184 dated 15th November, 1995. The said University has been included in the list of Universities maintained by the University Grants Commission under Section 2(f) of the UGC, Act, 1956.


The above University has, however, not been declared eligible to receive Central assistance in terms of Rules framed under Section 12B of the UGC Act, 1956.
