Summary Note

Sikkim Manipal University (SMU) maintains a comprehensive, multi-tier Ph.D. governance structure that fully incorporates and extends the UGC's prescribed framework.

- (a) At the department level, both DRC and RAC are constituted in accordance with UGC norms to separately address admission/registration functions and ongoing scholar monitoring.
- (b) At the institute level, the IRC serves as a coordination and quality assurance mechanism an additional layer established by SMU to strengthen research oversight.
- (c) <u>At the university level</u>, the URC serves as the statutory apex authority ensuring institutional compliance with the UGC (Minimum Standards and Procedures for the Award of Ph.D. Degree) Regulations, 2022*

- 5. Any change in Supervisor or Co-supervisor shall automatically update the RAC composition accordingly.
