Complying with the directives of the Hon`ble Supreme Court of India (vide its order dated 16 May 2007), AICTE Notification dated 01 Jul 2009 (issued vide F No 37-3/Legal/AICTE/2009) and UGC letter No F.1-15/2009 (ARC) Pt III dated 29 Apr 2014, the above Anti-Ragging Committee is formed for overseeing the implementation of the provisions of the Anti-Ragging verdict (available at [www.antiragging.in](http://www.antiragging.in) & [www.noragging.com](http://www.noragging.com) and e-mail : [infor@amanmovement.org](mailto:infor@amanmovement.org) and Mobile Nos 098711303, 098180116 only in case of emergency).

The Committee comprising faculty members, administrators and women representative will monitor the measures taken by the Institute for prevention of ragging, will look into the specific instances of ragging and complaints of ragging etc, and suggest appropriate actions/punishments against individuals indulged in ragging.
